\*Denver Area Cottey Club (DACC) is not a state philanthropy. Individual donations to DACC are not tax deductible. Chapter donations to the CCCC are considered local giving for tax purposes.



The Colorado P.E.O. Charitable Corporation (CPCC) is Colorado’s 501(c)(3) entity. It allows individual donations to the Marguerite Fund and the Chapter House to be tax deductible. The corporation’s name in 1949 was “Colorado Foundation Fund.” In 1965, the name was changed to “Colorado P.E.O. Chapter House, Inc.” In 2012, the name changed to “Colorado P.E.O. Charitable Corporation.” The name changes reflect the evolution of the charitable purpose of the 501(c)(3) organization. The CPCC provides administrative oversight and preserves, protects, and promotes the state’s two charitable funds.
