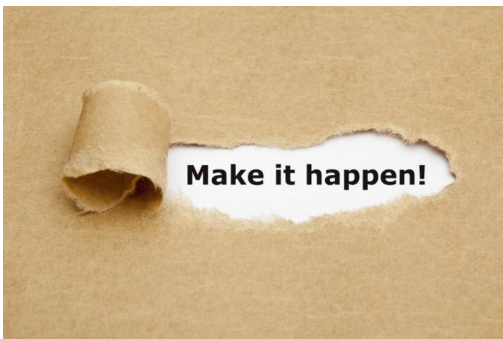


CPCC has asked to have this statement put into this newsletter:
