

A Head's Up! The Overarching Guidelines for P.E.O. Gatherings are still in place. The Executive Board of

International Chapter (EBIC) continues to review the Overarching Guidelines for P.E.O. Gatherings and reach out

for expert advice regarding our COVID-19 pandemic emergency decisions for all our sisters in Canada and the United States.



Remember that the current modified in-person, virtual and hybrid local chapter meeting procedures are temporary during this COVID-19 pandemic emergency. When restrictions are lifted, these modified meeting procedures will no longer be used. The EBIC is proposing amendments at the upcoming CIC to allow for in-person, virtual and hybrid local chapter meeting formats, along with amendments tied to these formats to the Procedure for P.E.O. Chapter Meeting.

Convention Registration is now OPEN!

Registration is open for P.E.O. Convention of Colorado State Chapter, which will be held online June 4-6, 2021. Convention is free for all attendees, so please attend!

To register, visit https://cvent.me/0KYn4x and follow the directions provided on the site. Registration closes on May 31 at 11:00 a.m.

This year's convention will follow a different format than previous years, and this affects how you will register. Please keep the following in mind.

- · You must have an email address to register-no exceptions. It must be unique from other attendees' email addresses.
- ·You need a Zoom account to attend convention. You can download the software to your computer from https://zoom.us/download. If you already have

- a Zoom account, please make sure you <u>update your software before</u> convention.
- · Everyone who registers through the link above will have access to Friday, June 4 and Sunday, June 6 activities. You will receive links for Friday and Sunday events on May 31 via email.
- If you are a **voting member of convention** (chapter delegate, state committee member, PSP), you will also be asked to sign up for **two additional** Saturday, June 5 sessions as part of the registration process. Once registered through Cvent, you can expect two additional emails with directions for requesting Zoom links from International for Saturday's meetings.
- •You alone are responsible for keeping track of the links you need to access each part of convention, so please save your confirmation email(s) so that you can retrieve the links when they are needed.
- Registration does not include an option for alternate chapter delegates. Alternates, if you would like to attend Friday and Sunday events, please register as an "Active P.E.O. attending convention."

The new convention format has created learning opportunities for all of us.

Colorado State Chapter now has a private Facebook group. If you have a Facebook account, you can use the search function to find the group by name, P.E.O. Colorado State Chapter.

As a private group, you will need to request to become a member by answering one question, "What are your Colorado Chapter Letters?" You might receive an invitation from another member, and when you accept the invitation, one of the administrators will accept you as a member.

International P.E.O. has guidelines for chapters, local, and state, for using social media. The short version of rules, shown below, is posted in the group, but there is a two-page social media guideline that you can find on the International website, https://www.peointernational.org/.

The main rules and etiquette are as follows:

P.E.O. International encourages members to come prepared to share successes, challenges, provide constructive feedback, bring questions, and provide perspective in all manners related to chapter life. Members must agree to follow the Rules and

Etiquette to ensure the group remains an open space to discuss issues and topics related to P.E.O. chapters.

Promotional messages are not permitted in P.E.O. groups.

- · Uphold the P.E.O. brand and our Objects and Aims.
- · Do not attack others. The discussions on social media are meant to stimulate conversation not to create contention. Let others have their say, just as you may.
- · Do not post commercial messages.
- · Group posts should not contain promotional material, special offers, job offers, product announcements or solicitation for services.
- · Fundraising posts please see Instructions to Officers of Local Chapters Fundraising Policy*.
- · All defamatory, abusive, profane, threatening, offensive language or illegal materials are strictly prohibited and will be removed.

*This information is found on International's website, https://www.peointernational.org/ Rules governing fundraising and circularization will be followed as well. One of my own pet peeves when I find a spelling, grammar, or other writing error is that I will edit my post. You can do this in any of your posts after you have submitted them. There are three little dots (an ellipsis) to the right of your post that clicked on gives you the opportunity to edit or delete your post. I will edit posts from 11 years ago when I catch them! If you are using a handheld device-phone or tablet, you hold your finger on your post and a menu will come up that allows you to edit.

Are you ready to have a Fundraiser? Does your chapter host a Tea or Luncheon? These fundraisers and many others are great ways to Promote P.E.O. Projects and the P.E.O. Sisterhood.

As you plan your event, make sure all you I's are dotted and your T's are crossed. Does your date conflict with Colorado State Convention or Convention of International Chapter? Could

it potentially conflict with a State Workshop? Ask a Board Member!!

Before you begin to advertise your fundraiser, please send your flyer or brochure to the Colorado State Executive Board for approval. International Standing Rule #2 requires approval of the State Executive Board for circularization among members, local chapters, reciprocity groups, P.E.O. Groups, or hostess groups.

· Circularization is defined as the circulation of letters, leaflets or canvassing by any other means (including social media, electronic or verbal communication) to other chapters and/or individual members of other chapters. This Standing Rule also includes social correspondence such as fundraising flyers which is not considered circularization but requires approval.

Fundraising advertising needs to be consistent with the P.E.O. standards. All advertising needs to include the following phrase:

"P.E.O. chapters support the educational and charitable funds of the P.E.O. Sisterhood but are not classified as charitable by the IRS. Therefore, donations to individual chapters do not meet the IRS requirements for a charitable income tax deduction. P.E.O. shall not be liable in any way for any goods and services supplied by third-party vendors or public establishments."

Please send all fundraising advertising flyers to the Executive Board for prior approval. The EB will reply within 3 days. Email to: costatechapter@gmail.com
