#### **Chapter House:**

All is well at the Chapter House with residents and employees. COVID-19 precautions remain in effect. The board has decided to continue the current restrictions prohibiting chapter meetings (inside or outside) or visitors other than family until the relevant numbers improve in El Paso County. We are monitoring until early June and then reconvening the subcommittee to consider again.

The newest adventure at the Chapter House property involves a recent letter from the Colorado Division of Water Resources regarding its review of all ponds within the Arkansas River Basin to "more accurately manage our water supply and to meet our legal water obligations to Colorado water rights and a downstream state [Kansas]." The letter is notice that we have *neither* a legal water storage right nor a legal water source to fill our pond. The board and our CH manager are gathering information regarding the options that may be available to us regarding this issue. Stay tuned.
