New Year greetings to our Colorado Sisters. May 2022 be a good year for us all.

CPCC is happy to announce that the Colorado P.E.O. Chapter House has been sold. The gross selling price was \$2.3 million. The closing was December 28, 2021, and the keys were transferred on December 30, 2021. It was a good way to end the 2021 year and an opportunity for CPCC to start 2022 with a focus on our other projects.

The Marguerite Fund Trustees report that they provided aid for monthly recipients in the amount of \$9,000 plus a one time gift of \$750. In addition, they were able to give their monthly recipients a Christmas bonus totaling another \$9,000. In January 2022 there will be 18 recipients receiving monthly checks. Colorado P.E.O. sisters are thanked for their continued support of the Marguerite Fund project that allows the Trustees to grant this aid to people in need.

### You Are the Marguerite Fund

The Colorado P.E.O. Marguerite Fund (the Fund) was established with \$1,200 in 1923 to help women in need throughout Colorado. For nearly 100 years it has grown and done just that. At the time of this writing there are 17 women who will each receive \$500 in February.

The Fund is maintained entirely through donations from individuals and Colorado P.E.O. chapters. It does not receive monetary support from P.E.O. International.

The horrific wildfires that swept through parts of Boulder County on December 30 completely destroyed over 1,000 homes and left many others damaged. Among those destroyed were the homes of ten of our P.E.O. sisters, five from just one chapter. Countless other sisters and their homes have been affected.

The Trustees of the Fund are aware of the needs not only of our sisters, but also others whose lives have been altered in unimaginable ways. While a monthly stipend of \$500 will not repair the damage, it will provide steady support for unexpected and perhaps uninsured expenses.

If you know of someone who would benefit from help from the Fund, you may want to consider sponsoring her. If you are able to contribute to the Fund, be assured that your gift, no matter the size, will be carefully managed and will aid those who are in need.
