**Ad Hoc Committee
New Chapter House
Project**

The CPCC Board of Directors plans to appoint an ad hoc committee to research and propose a new Chapter House Project. This will be a short-term committee (6 months maximum) with two charges: 1) study what other P.E.O. state chapters have done with the proceeds from the sale of chapter house properties, and 2) develop a proposal for utilizing the proceeds from the sale of the Colorado State Chapter House that conforms with the CPCC Articles of Incorporation and Bylaws.



The committee will consist of members from the CPCC Board and Chapter House Trustees and members at-large representing the entire state. We anticipate that all meetings will be conducted via video conferencing.
