#### **NEWS OF AND FROM THE CPCC WEBINARS**

Each webinar began with an explanation of the resolution that the CPCC Board plans to present at the CPCC Annual Meeting in June 2024. Based on the majority results from the survey sent to all Colorado chapters, the resolution will call for the proceeds from the sale of the Colorado P.E.O. Chapter House to be given to the P.E.O. Foundation and split equally between the two existing state funds: the Colorado State Scholarship Fund and the Colorado Cottey Scholarship Fund. Contrary to what was announced earlier, the 50/50 split between the two state funds is not required by the Foundation. A different division of the funds could be offered via an amendment during the debate of the resolution.

Board members explained that moving the sale proceeds to the Foundation would require divestiture from mutual funds and stock investments where they are currently held. This would not be done until the decision is made at the annual meeting.

Board members also explained that the sale proceeds money placed in the Foundation

could not be included in any distribution for at least one year because of Foundation policies. The state scholarship committees are notified each year how much money is available for distribution. The committees determine the recipients based on the applications received.

Additionally, Board members also stated at the webinars that the finance committee of the P.E.O. Foundation is holding a special meeting to discuss this potential gift from the CPCC. After the webinars the Board learned that the reason for this meeting is because the lawyer for International is concerned about using money that was originally donated to a welfare/housing mission to a different mission: education. The fact that this proposed mission change is coming because of a statewide survey and after two webinars on the proposed change is to CPCC's credit and shows the members' support for the change.

#### WHAT HAPPENS NEXT?

The Board plans to meet at the end of November by which time we hope to learn about the Foundation's finance committee decision. We have invited Colorado's representative on the Foundation Trustees to join us for that meeting, and she has accepted.

Another possible action has also emerged from our conversations with personnel at International. We could establish a new and separate fund in the Foundation that would distribute earnings back to the Chapter House Project to be used for the charity of our choice: education. Other chapters have established similar funds, so we know this can be done. This could circumvent the legal concern and allow Colorado to establish a new scholarship for a wider variety of academic recipients.

Both approaches will be discussed at the November Board meeting.

Yes, the Board is still planning to send documents to the state A & R committee by early December.

We are certainly grateful for the ability to work together!

To answer the question about those ladies that were put in upheaval mode when the Chapter House was sold, Article XI under "Share the Care" spells out for us that the assistance continues until there is no longer a need. We have no way of determining that timing. CH Trustees recently confirmed the continuing need of these women through the annual process.
