CPCC MARCHES ON!

Last month we reported that we had submitted proposed amendments to the Colorado P.E.O. Charitable Corporation Articles of Incorporation to include education as one of our purposes and proposed amendments to the Bylaws for two different educational projects using the sale proceeds from the Chapter House residence. Those proposals were sent to both Colorado's Amendments and Recommendations (A&R) and International's Study and Research (S&R) committees.

During this past month all three groups, the CPCC Board, A&R and S&R, have been discussing and refining those proposals before they are published for the entire membership on May 1. The guidance of both the A&R and S&R committees has been most helpful to ensure that we have considered all the various issues raised when creating this potential new state project.

We want all our sisters to understand each proposal, to discuss them with their chapter sisters, and to send their convention delegate to CPCC's annual meeting with the knowledge of which factors are important to your chapter when participating in the debate and voting on the two proposed projects. There will be a choice to make!
